CERTAIN DISTRICT COURT RULES

Administrative Order: 19-03

The Chief Judge is responsible for supervising the administrative business of the Eighth Judicial District Court (EJDC), ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court's duties are timely and orderly performed, and otherwise facilitating the business of the EJDC. EDCR 1.30(b); *see also* NRS 3.025.

By order dated December 31, 2018, the Nevada Supreme Court amended the Nevada Rules of Civil Procedure (NRCP), Nevada Rules of Appellate Procedure (NRAP), and the Nevada Electronic Filing and Conversion Rules (NEFCR). The rule amendments became effective March 1, 2019. The Nevada Supreme Court further ordered the amended rules control when conflicts arise between the amended rules and the local rules of the district courts.


For the benefit of the bar and to ease confusion until the EJDC amends its local rules to conform to the amended NRCP, NRAP, and NEFCR, the EJDC finds it necessary to suspend or modify certain District Court Rules. Additionally, to the extent any other rule of the Eighth Judicial District Court conflicts with the revised NRCP, NRAP, and NEFCR, the NRCP, NRAP, and NEFCR control.

IT IS ORDERED the following rules are suspended or modified until further notice:

1. Rule 1.14(a) through (c) is suspended;
2. Rule 1.90(a)(2) is modified to strike references to the discovery commissioner and replace those references with "district judge";
3. Rule 1.90(b)(3) and Rule 1.90(b)(4) are suspended;
4. Rule 2.20(b) is suspended. Motions requiring a hearing must include the designation "Hearing Requested" in the caption on the first page of the motion as follows:

5. Rule 2.34(f) and Rule 2.34(h) are suspended;
6. Rule 2.35(a) is modified to strike references to the discovery commissioner and replace those references with "district judge" as the district judges will handle stipulations or motions to extend discovery deadlines;
7. Rule 2.55 is suspended;
8. Rule 5.602(g) is suspended;
9. Rule 8.01 and Rule 8.03 through 8.16 are suspended.
